

### **FRNV Vision**

### **Our National Values**

The solution to the value crisis lies in the inspiration provided by the three stable pillars on which independent India has vouched to rest firmly:

- 1. National Motto; 'Satyameva Jayate'; signifying that 'truth shall prevail', which we chose for ourselves, in the wake of independence.
- **2.** *National Flag*; that proclaims ceaselessly the message of inner sacrifice, inmost purity, preservation of natural abundance, and vitality of the Earth.
- **3.** Fundamental Duties in the Constitution; enjoining each one of us to value and uphold the composite culture of our country, and to be inspired by the great ideals that led our national struggle for independence. Together, these make an exquisite triangle encompassing all our National values, and FRNV draws its inspiration from this ocean of strength.

### **Our Focus Areas**

Towards creating a Value-based Society, FRNV focuses on the following areas:

### 1. Values-Based Education:

The main focus of this project is to implement FRNV's Values-based education methodology across schools in our country. FRNV's mission is to become known as an 'Opinion Leader' in the area of Values-based education in the country.

### 2. Electoral and Administrative Reforms (including Judicial Reforms):

FRNV will focus on achieving the following:

- Prevention of people with criminal background from contesting elections.
- Prevention of money and muscle power in conduct of elections.
- Legislative backing to implement code of conduct during elections.
- Speedy disposal of poll petitions and criminal cases against poll candidates.
- Ensure accountability of elected representatives to the electorate.
- Improve transparency and effectiveness in public administration.
- Ensure greater governance with less government; and Speedy disposal of pending cases in courts.

### 3. Police Reforms:

- FRNV will focus on achieving the following: -
- Implementation of recommendations made by the Supreme Court.
- Prompt registration of First Information Reports and Investigation.
- Proper follow up of prosecution cases in courts.
- Making police people friendly, and Setting up of effective Police Complaints Authority (PCA) and prompt deterrent action against offenders.

### 4. Sanitation and Hygiene:

FRNV advocates on waste segregation, solid-waste management and educating citizens about civic sense.

### 5. Corporate Engagements for Ethics & Governance:

At the Foundation for Restoration of National Values, we believe that corporate integrity is important to attain sustainable development. We seek to stimulate the inner consciousness of corporate leaders and strive to maintain a high level of transparency within the organizations.

### **Our Regional Chapters**

FRNV does not restrict itself within the region of Delhi and aims at expanding its motives to all parts of the country. The efficient functioning of the regional chapters will ensure effective implementation of police reforms in the different states as per Supreme Court directives, implementation of value-based education in the different tiers of education across all state of the country and to implement electoral and administrative reforms across the nation in an attempt to prevent value erosion and eradicate corruption.

During the year, the Governing Body approved the following structure for its Regional Chapter:-

- 1. Chairman/Chairperson (earlier Convener)
- 2. Vice Chairman
- 3. Secretary
- 4. Treasurer

Regional Chapters may also designate its member(s) as Jt. Secretary and Jt. Treasurer based on organizational strength and requirements.

Chairman/Chairperson and Secretary will be representing the Regional Chapter with FRNV HQ during meetings, etc.,

Foundation for Restoration of National Values has six Regional Chapters:

### 1. Kerala Chapter-Kochi

Kochi Chapter is headed by Dr. Devika Menon under direct the guidance of Honorary Life President Dr. E Sreedharan. They are doing work on value education for students and disaster management.

### 2. Karnataka Chapter-Bangalore

Karnataka Chapter is headed by Sri S L Gangadharappa. The chapter was launched on August 13, 2016, at Bengaluru. This chapter has been working in the following areas: Values-based Education, Corporate Integrity and Police Reforms.

### 3. Tamil Nadu Chapter - Chennai

Tamil Nadu (Chennai) Chapter is headed by Dr. T S Sridhar, IAS (Retd.), who took over as Chairman of the Chapter from 6th March 2024 as recommended by Sri Mahalingam Balasubramaniam. The chapter has taken up the Teachers' Manual and translated in Tamil, Malayalam and Kannada languages. The chapter has been working on Values-based Education, etc.

### 4. Haryana Chapter-Hisar

Haryana (Hisar) Chapter is headed by Sri Jagdeep Bhargava. Shri Bhargava took over as Chairman of the Chapter on 2nd July 2022 in Hisar. The chapter has been working on Values-based Education, etc.

### 5. Odisha Chapter – Bhubaneswar

Odisha (Bhubaneswar) is headed by Dr. Arun Kumar Rath, IAS (Retd.). Odisha Chapter was inaugurated on 29th October 2023. Since then, the Chapter has undertaken membership drive and conducted two workshops on Values & Ethics. The Chapter has enrolled 15 life members and 3 annual members.

### 6. Delhi Chapter

The Delhi Chapter was launched on 8th February 2024. It is headed by Dr. Manoj Singh, former Director/AIIMS/New Delhi. The Chapter has enrolled about 4 life members and 5 annual members in a very short time.

### FRNV Activities 2023 - 2024

- 1. Activities during the year 2023-2024 were as under:-
- a) The 15th Annual General Meeting of FRNV was held on 16th September 2023 at 4.30 pm in Hybrid mode (physical & virtual) in the Registered Office of FRNV.
- 2. Review of FRNV performance reveals that with regular weekly participation by Governing Body members and involvement of regional chapters, FRNV had been able to achieve the following:
- I. Regular bi-monthly issue of print-journal "Value Insight" commenced from June 2022. Regular issues were printed in April 2023, June 2023, August 2023, October 2023, December 2023 and February 2024.
- II. Inspiring and involving all six Regional Chapters in regular monthly meetings.
- III. Four School Workshops were conducted in
  - (a) Kamal Model Sr. Sec. School, Mohan Garden (12.08.2023),
  - (b) Ramjas International School/R K Puram (20.01.2024)
  - (c) Balvantray Mehta Vidya Bhawan/Greater Kailash (05.02.2024) and
  - (d) NGO Khushii/Sangam Vihar/New Delhi (20.03.2024).
- IV. One Corporate Workshop was organized on 13th February 2024 for Apollo Hospitals/New Delhi.
- V. Deliberations considering ways and means for organizing seminars for Corporates, forming a team, to work out a way forward at the earliest and also take up value education in a few schools.

### **Strengthening the Organization**

More regional centres with active members are required. New chapters at Bhubaneswar (Odisha) and Delhi were set up.

### Value-based Education

The recommendations of FRNV on Value-Based Education have generally been accepted by the Government of India and have been included in the New Education Policy (NEP) 2020.

Most of the State Governments had taken steps to implement the NEP 2020.

The Government had constituted under the chairmanship of Dr. Kasturi Rangan to design curricula and syllabus as per NEP 2020.

### **Corporate Integrity:**

At the Foundation for Restoration of National Values, we believe that corporate integrity is important to attain sustainable development. - I. The Governing Body re-iterated the following for FRNV:-
- · National Values
- Constitutional Values

FRNV promotes National Eternal & contemporary Values which are already enshrined in the National Flag, the National Moto, 'Satyamev Jayate' (Truth Alone Triumphs) and the Fundamental Duties as enshrined in the Constitution. Some of these values are eternal:

Truth, Non-violence, Righteous conduct and Preservation of natural abundance and vitality of the earth. Other Values which we promote are Contemporary Values. These are: Justice, Liberty, Equality, Fraternity, Sensitivity, Teamwork, Discipline, Responsibility and Respect for self as well as others.

Out of the above, Equality (opportunity to everyone), Compassion (care and service to others), Non-violence, Integrity (innermost purity, honesty), and Discipline/respect for rule of law shall be the focus values.

- Universal Values simultaneously, following Universal Values shall be adhered by FRNV and its members:
  - a) Truthfulness
  - b) Righteousness
  - c) Non-violence
  - d) Compassion
  - e) Bhakti devotion to God, Desh Bhakti, Mother, Father, Guru and God



### Re-organization to Advisory Board

Based on our request, Shri O P Rawat, IAS (Retd.) and former Chief Election Commissioner and Justice Mahesh Grover of Punjab & Haryana High Court have kindly agreed to be Advisor in FRNV Advisory Board. ### **Corporate Workshop:**




